Exciting things are happening at FamilyForward! We are changing lives in profound ways.

This past year, with professional guidance from Dr. Bruce Perry and the ChildTrauma Academy, we officially launched the FamilyForward Developmental Trauma Center. Through this achievement, FamilyForward is able to provide the St. Louis region and beyond with access to resources and highly trained staff who will use the Neurosequential Model of Therapeutics (NMT) assessment process to offer individualized interventions for children who have experienced abuse, neglect, or other trauma.

We are seeing tangible results almost daily. When seven-year-old Ryan came to FamilyForward, he had already been given multiple diagnoses and took a variety of medications. Even so, he was still having trouble regulating his behavior and was struggling in school. Our assessment showed that Ryan was dealing with the effects of significant childhood trauma. We were able to help his caregivers understand the underlying cause of his behavior and suggest specific interventions to meet his needs.

I believe the Developmental Trauma Center represents a significant enhancement for how FamilyForward helps children and families, and it embodies our continued commitment to innovation — being **out front** and setting the pace in moving vulnerable children in the direction of hope.

We are very proud of our services and the numbers of individuals served as reflected in our 2017 Annual Report. They demonstrate

that we remain **rock solid** — we have been responsible stewards of an organization with a long and proud legacy of providing help to children and families impacted by abuse and neglect. We are currently working with The Rome Group, specialists in nonprofit performance effectiveness, to create a strategic plan that will ensure our continued commitment to that legacy as we move forward with our mission.

This Annual Report has a purpose beyond numbers though. We are inviting you to journey with us into our work, and the stories, hearts, and aspirations of our kids, their families, our donors, and amazing staff, who are **whole hearted** in their commitment to the vision and mission of FamilyForward.

Footsteps on the porch, a face at the window... We didn't have to dig deep to understand Brittany's anxiety, jumpiness, and irritability, as her abusive

Despite her own fears, Brittany came to FamilyForward seeking help for her children, not herself. She knew her son's stomach aches were a clear sign of distress, and her four-year-old daughter was clinging to her. "Kids are really scared when they see violence in their home," FamilyForward's therapist says. "And this trauma was ongoing: their father's menacing figure lurked around their home, the library, and even their church."

When Brittany was ready to address her own needs, FamilyForward's Redevelopment Opportunities for Women (ROW) programs embraced her. "Brittany and her children needed a safe place to call home," her ROW advocate says. "We have worked with her to get an order of protection against her abuser, and we are helping her to save money so she can move."

"FamilyForward has empowered me and makes me hopeful for the future," Brittany says. "This place has been a godsend."



DEVELOPMENTAL TRAUMA CENTER LAUNCHES



The majority of children served by FamilyForward have experienced some type of abuse or neglect, resulting in developmental trauma. Recognizing that there is no one-size-fits-all treatment plan for these children, we have opened the region's first and only Developmental Trauma Center, which incorporates the Neurosequential Model of Therapeutics (NMT) to provide a comprehensive approach to understanding the impact of significant childhood trauma.

Developed by Dr. Bruce D. Perry, MD, PhD, founder of the ChildTrauma Academy and an internationally recognized authority on childhood trauma, NMT offers individualized treatment plans to support children at home, in school, and with therapeutic intervention. FamilyForward was the first agency in the

St. Louis region to become site certified in the use of NMT in 2015.

"Each child's trauma history is unique, as is the impact of that trauma on their brain development," FamilyForward Chief Program Officer, Rachel Neukirch, notes. "We have established the FamilyForward Developmental Trauma Center to provide clients, clinicians, and the community with greater access to our knowledge and expertise regarding developmental trauma."

She's Amazing

When Kiki first came into foster care as an infant, she was severely malnourished and had three broken ribs. Chris, her foster/adoptive mother, thought unconditional love would be enough to overcome the effects of abuse and neglect, but by the time Kiki reached middle school she was struggling socially and academically. Her teachers began to discourage any thought of high school.

Chris was undaunted however. She knew that Kiki was capable, smart, and talented, so she turned to FamilyForward for the tools and expertise to help her daughter succeed.

FamilyForward utilizes an innovative assessment tool, the Neurosequential Model of Therapeutics (NMT), to provide a comprehensive approach to understanding a child's trauma history and their current functioning. This allows clinicians and caregivers, such as Kiki's mother and her teachers, to implement individualized therapeutic activities that meet the child's specific needs.

Kiki just completed her sophomore year of high school and qualified for the honor roll for the first time. Chris says her daughter is not only capable and smart: she's amazing.
