TAKING STEPS TOWARD POSITIVE CHANGE

Crystal and Steve Jackson, along with their four kids, found themselves struggling in their new, too-small rental home when they moved to St. Louis. Relations with the children's new school quickly grew strained when three of the four children began to regularly miss class due to illness.

Things began to spiral out of control when the school referred the Jacksons for services because there was concern that the family was at risk.

With no one to turn to for help, Crystal was afraid of losing their children. "One day, we passed by FamilyForward's sign and I remember thinking that with a name like that, it must be a place where families like us could get help."

FamilyForward's Community Services help families address challenges related to safety, social connectedness, and stability. Through comprehensive coaching and therapy, the Jackson family was able to develop social supports within their community and learn how to cope with stressors more easily.

For the first time, Crystal was able to address her personal history of abuse and how it affected her parenting. The children learned more about their chronic illnesses, as well as their educational rights and responsibilities. Together, the Jacksons developed safer, healthier ways to support each other.

When asked what she would tell a parent whose family is struggling with the pressures of everyday life, Crystal said: "Life's journey is never complete. You can change and have something so much better for your family than what you have now."

B7 DEVELOPMENTAL TRAUMA CENTER

FamilyForward is site certified in the Neurosequential Model of Therapeutics (NMT) by the ChildTrauma Academy. Assessment, treatment, and parent education services engage the child, family members, teachers, therapists, and other professionals. FamilyForward's Therapeutic Preschool serves children ages three to five who have experienced early adversity, utilizing trauma-informed, developmentally sensitive interventions.

651 **COMMUNITY SERVICES**

Coaching and mentoring to address family stressors such as safety, shelter, unemployment, and parenting. Individual, family, and group therapy provided in-home and in-office using evidence-based practices.

498 REDEVELOPMENT OPPORTUNITIES FOR WOMEN (ROW)

Advocacy and financial literacy services for women who have been impacted by domestic violence and economic hardship. Empowering women and their families to build safety, skills, economic security, and hope for the future.

421 FOSTER CARE

Foster care case management, as a member of Children's Permanency Partnership. Recruitment, training, and licensing for foster and adoptive families.

61 CARE FOR CHILDREN WITH DEVELOPMENTAL DISABILITIES

FamilyForward Children's Homes provide long-term, 24-hour residential care and short-term, 24-hour respite care for non-ambulatory children ages 0-21 with developmental disabilities and significant medical needs.

UNDERSTANDING THE IMPACT.

The first thing we noticed was Sophie's speech impairment. When she spoke, she only used partial words in a halting, stunted way. Her difficulty speaking and daily tantrums were clear indications of emotional trauma. Sophie was unable to self-regulate and control her impulses the way people expected. She was in her second preschool and second foster care placement when her frustrated caregivers turned to FamilyForward for help.

Our trauma assessment of Sophie utilized a comprehensive and respectful approach to understand her development and the impact of her childhood trauma. The assessment provided realistic expectations and a clear treatment plan based on Sophie's individual needs. Today, only months after the initial assessment, we have already seen a tremendous improvement in Sophie's speech and behavior – allowing her to move forward.

We are responsible stewards of an organization with a long and proud history of service. Reliable, trustworthy, and hard-working, we do whatever it takes to advance safer, healthier relationships for children and families.

We budgeted an operating loss for 2018, the first full year since the April 2017 merger that resulted in FamilyForward. This loss was budgeted to be offset by investment gains, but a stock market downturn late in 2018 caused investment losses for the year. These unrealized losses were completely recovered early in 2019.

FamilyForward's 2019 operating budget is \$11,605,198. We will continue to move vulnerable children and families in the direction of hope.
